INVESTIGATION FINDINGS

ADEQ Air Inspector conducted an investigation at the site on August 2, 2018, and another visit was made to the site on August 8, 2018. Mr. Ellis provided six (6) photos taken at the site, three (3) on each day, to show the current conditions he observed while there. (Refer to attached Photolog.) Mr. Ellis described this facility as a "Stump Dump" that was allegedly begun by local authorities years ago. This property was purchased by BTS Equipment, LLC. in January 2018. BTS Equipment LLC is co-owned by Cletus Wilkins and Karena Wilkins, according to Mr. Ellis who made contact with Karena Wilkins through a telephone conversation concerning the fire. A multi-media site visit was conducted by ADEQ personnel on August 15, 2018. Photographs of the site were taken in order to record current conditions/observations. (Refer to Attached Photolog.)

APC&EC Regulation 22.102 defines Class 4 solid wastes as nonhazardous, bulky, inert, nonputrescible solid wastes that do not degrade, or degrade very slowly, and are permitted by the Department to be disposed of in a Class 4 landfill. Class 4 wastes include construction and demolition wastes, appliances, furniture, stumps, limbs, and other bulky wastes that are not normally collected with other household, commercial, or industrial waste.


APC&EC Regulation 22.102 and A.C.A. § 8-6-203 defines a disposal site, in part, as any place at which solid waste is dumped, abandoned, or accepted, or disposed of for final disposition by incineration, landfilling, composting, or any other method.

The property on Trafalgar Road meets the definition of a disposal site. This disposal site is filled with various wastes, and therefore, must have a permit from the ADEQ. Upon review of current records, it was revealed BTS Equipment, LLC, does not possess a valid permit for this disposal site of various wastes from the ADEQ. This is a violation of APC&EC Regulation 22.1502(a) and A.C.A. § 8-6-205(a)(2) which states, in part, it is unlawful to construct, install, alter, modify, use or operate, any solid waste disposal or processing facility or site without a permit from the Department.

Upon referencing the photos, newly deposited materials (tree logs, limbs) were observed on the landing, near where the smoke is rising into the air. This is a violation of A.C.A. § 8-6-205(a)(3) which states it shall be illegal for any person to dispose of solid wastes at any disposal site or facility other than a disposal site or facility for which a permit has been issued by the Department.

Again referencing the photos, smoke can clearly be seen rising just beyond the northern edge of the platform, along the eastern edge of the platform, along the north-western edge of the platform, and also to the south of the northern edge. (Refer to Photos #1 - #6.) The rising smoke and/or the contents within it, is construed to create a public nuisance as evidenced by the original complaint being made to the ADEQ, possibly a public health hazard due to unknown materials burning from within the waste mass, and is the cause of air pollution. This is a violation of A.C.A. § 8-6-205(a)(5) which states it shall be illegal for any person to sort, collect, transport, process, or dispose of solid waste contrary to the rules, regulations, or orders of the Department or in such a manner or place as to create or be likely to create a public nuisance or a public health hazard or to cause or be likely to cause water or air pollution within the meaning of the Arkansas Water and Air Pollution Control Act, § 8-4-101 et seq.
