The Arkansas Department of Environmental Quality (ADEQ) has reviewed the Resource Conservation and Recovery Act (RCRA) renewal permit application submitted by Rineco Chemical Industries, LLC on January 19, 2018, revised May 4, 2018, September 13, 2018, and October 8, 2018 to ensure compliance with Arkansas Pollution Control and Ecology Commission (APC&EC) Regulation No. 23. ADEQ proposes to issue a renewal permit to Rineco for the treatment and storage of hazardous waste. If approved, the draft permit will become RCRA Permit No. 28H-RN2.

Individuals may review the application and the administrative record in the ADEQ Records Management Section, Arkansas Department of Environmental Quality Building, 5301 Northshore Drive, North Little Rock, Arkansas, or at the Haskell City, Hall, 2520 AR Highway 229, Benton, AR 72015.

ADEQ will make a final permitting decision on the draft permitting decision following the end of the public comment period. ADEQ will hold a public hearing at 6:00 PM on February 13, 2019 at the Haskell Community Center located at 539 East Elm Street in Haskell, Arkansas.

Submitting written comments to ADEQ or making oral statements on the record at a public hearing on the draft permitting decision provides individuals with legal standing to appeal a final ADEQ decision. Comments supporting or opposing the tentative decision will provide legal standing. Only parties with legal standing may appeal the final decision.
