Ms. Vanourny,

Thank you for contacting me on this matter. The final NPDES Electronic Reporting Rule (attached) became effective December 21, 2015. This will require all NPDES permit holders to begin submitting their DMRs electronically via NetDMR by September 21, 2016. A Reporting Rule Timeline is attached for your reference.

The Change in Signatory form may be used to add/change responsible officials, cognizant officials, contact emails and designate who will receive your paper DMRs until NetDMR goes into effect.
