Dear Bailey,

This letter is in response to your certified mail dated July 6, 2017.

The violations in Marion's discharge are from three episodes, one in May of 2016, one in June of 2016 and again in May of 2017. Our treatment process is waste stabilization ponds. Historically ponds of this type in the spring usually have permit violations in the form of Suspended Solids due to a healthy growth of algae. What is unusual about these current violations in Marion's discharge is the fact that we exceeded our limits in BOD.

Our research has found extreme rainfall episodes in the spring of 2016 and 2017. The only thing that makes any sense is these samples were collected during the time that we would suspect a pond turn over. Cold rain water on top would find its way toward the bottom bringing up a concentration of BOD from the anaerobic zone normally found at the bottom. With our detention time and the fact that the ponds are not close to being overloaded there aren't many circumstances that would point toward some corrective action.

Please note that Marion has not had a violation since May. The Utility Personnel, beginning immediately, will be more sensitive to the conditions discussed above and exercise the option of not discharging during similar future circumstances. This seems to be the most logical corrective action to be taken.

Good Morning Bailey,

Obviously City Personnel do not have the capacity to run a five day BOD. They can check DO. They have 50 acres of pond which provides 16 million gallons per foot of pond depth for storage. The advantage of pumping discharge to the Mississippi River does provide the storage capacity to hold the waste. Our suggestion was to NOT discharge during those rain events that would be suspect to cause pond turn over. Generally infiltration inflow volumes lag behind the actual rainfall event. These should make reasonable circumstances for them to hold discharges temporarily.
