Paragould Light, Water and Cable Wastewater Treatment Plant NPDES Permit AR0033766 Toxicity Reduction Evaluation Status and Progress Report

As required by the National Pollutant Discharge Elimination System (NPDES) permit AR0033766, Paragould Light Water and Cable (PLWC) offers the following information to meet the Whole Effluent Toxicity requirements stipulated in the interim permit limits.

According to the Toxicity Reduction Evaluation (TRE) approved by the Arkansas Department of Environmental Quality (ADEQ) on July 2, 2015, Whole Effluent Toxicity (WET) samples are to be taken and analyzed quarterly to identify and eliminate potential sources of effluent toxicity. To date, nine (9) quarterly WET samples have been collected for analysis as outlined in the following table. No lethal or sub-lethal effects were revealed during any of the WET tests.
