Dear Mayor Strabala,

Enclosed is your signed copy of Consent Administrative Order (CAO) LIS 21-035. The Order will become effective on June 8, 2021. The Order was sent for Public Notice on May 9, 2021.

Per the Order and Agreement Section of CAO LIS 21-035, the City of Stuttgart has agreed to:

- On or before June 8, 2021, submit a response that adequately addresses the violations cited in the December 12, 2019 inspection.
- On or before June 8, 2021, submit to DEQ a complete Notice of Intent and SWPPP to obtain coverage under the NPDES Industrial Stormwater General Permit.
- Comply with the NPDES Industrial Stormwater General Permit, ARR000000, with the effective date of July 1, 2019.
- On or before August 7, 2021, submit to DEQ, for review and approval, a comprehensive Corrective Action Plan (CAP) and milestone schedule, prepared and stamped by a Professional Engineer licensed in the state of Arkansas.
- On or before August 7, 2021, submit a staffing evaluation and operations plan prepared and stamped by a Professional Engineer licensed in the state of Arkansas.
- On or before the fifteenth (15th) day of the month following each calendar quarter, and continuing until this Order is closed, submit quarterly progress reports detailing staffing schedules and progress made towards compliance with the milestones of the approved CAP and include photographic evidence of the work being completed. Report due dates are July 15, October 15, January 15, and April 15 respectively.

- On or before June 30, 2022, submit a final compliance report prepared and stamped by a Professional Engineer licensed in the state of Arkansas certifying compliance with the Permit and that all actions identified in the approved CAP and milestone schedule have been completed and that the facility is in compliance with the permit.
- Pay a civil penalty of Eight Thousand Eight Hundred (\$8,800.00) Dollars, of which Three Thousand Eight Hundred Dollars (\$3,800.00) is due by July 7, 2021. The remaining Five Thousand Dollars (\$5000.00) is conditionally suspended pending satisfactory completion of the terms of CAO LIS 21-035.
