**Progress Report 16 Summary** 

Major changes that have been implemented at the Walnut Ridge Wastewater Treatment Plant since November 15, 2023 are as follows:

- 1. Settling times in each SBR tanks were changed from 45 to 120 minutes.
- 2. Post decant run times for the disinfection equipment were increased from 60 to 600 seconds.
- 3. Waste activated sludge pumps 1, 2, & 3 were disassembled, cleaned and flow rates verified. The waste activated sludge rates were changed from 2 to 10 minutes.
- 4. The contact chamber and post aeration chamber were pumped down and cleaned of all solids.
- 5. Additional Mercury sample bottles have been ordered and sites have been selected for testing in the collection system to isolate an area as a point source.

Currently, all grab and composite samples have been in compliance for the month of December, with the exception being Mercury.
