- 2009 A CAO was issued to Rogers Group for failing to complete a stack test at Cabot Asphalt within the stipulated time frame. The stack test was completed, submitted to ADEQ and accepted.
- 2010 A NOV was issued to Rogers Group for not properly installing a V-notch weir to allow for flows to be estimated at Cabot Quarry. The weir was sent back to the fabricators and corrected to obtain more accurate estimates.

Rogers experienced a near miss at the intersection near the asphalt plant at Cabot Quarry. To prevent an accident from occurring there, RGI cleared the area on the permitted property to improve site distances in the area. During a water audit an old valve was found that drained the site pond. While the valve was closed this was considered a bypass. RGI capped the line and permanently removed from service.

- 2013 -A NOV was issued to Rogers Group Beebe Quarry for staining on the ground related to an overturned drum and berm maintenance. Rogers remediated the site to ADEQ's satisfaction.
- 2014 A NOV was issued to Rogers Group Beebe Quarry for encroaching on the 50' buffer zone by the mining section. Area was remediated and closed out with ADEQ.
