The Department has reviewed the City's 2012 Annual Report. The report has deficiencies:

1. The City sampled only once for Table III parameters at the North Plant (AR0040967). The new permit issued on April 23, 2013 requires the city to sample the influent and effluent at least quarterly. See excerpt below from paragraph 7.C:

C. The permittee shall analyze the treatment facility influent and the toxic pollutants listed in 40 CFR 122 Appendix D (NPDE: Requirements) Table II at least once/year and the toxic polluta quarterly (Jan-Mar, Apr-Jun, Jul-Sep & Oct-Dec). If, based up

Since the City sampled the effluent at least four times for copper and zinc (see attached DMR report), the Department will accept the DMR data to satisfy this requirement for only this 2012 Annual Report. Please instruct your lab technician to sample the influent and effluent quarterly at the North Plant.

- 2. The City violated the WQ limit (85.53 μ g/l) on July 17, 2013 by discharging wastewater with a zinc concentration of 110 μ g/l.
- 3. In reference to the City's letter dated August 6, 2012, the City has concluded that local limits for all pollutants are not necessary at this time (metal finishers are excluded). The Department's understanding at this time is that the City wishes to reserve the right to place local limits for metals and cyanide in metal finisher permits and that all other SIUs are exempt from all local limits. Therefore, the City should discontinue placing non-metal finisher SIUs in SNC for local limit violations and should issue only NOVs to these SIUs until their permits expire. In other words, the City should not place SIUs in SNC for violating BOD and TSS limits and should remove local limits for BOD and TSS from future renewed permits.

The Department appreciates the City's continued efforts in annual reporting and the City will not be required to submit any additional information for the 2012 annual report.

The Van Buren Municipal Utilities has reviewed the above referenced audit/assessment and have the following responses:

B) FINDINGS WITH REQUIRED ACTIONS

1) Calculations of Headworks Loadings reflect that the development of local limits is not necessary at this time.

C) RECOMMENDED POTW ACTIONS

- 1) Calculations of Headworks Loadings reflect that the development of local limits is not necessary at this time.
- 2) Derivation of mass limits has been removed from the River City Coating permit.
- 3) VBMU staff has requested a proposal from FTN Associates to develop a WER for the North Plant, and have requested information from ADEQ. (Letter attached)
- 4) There are two main pump stations that discharge into the South Plant, 4th Street Pump Station and S. 28th Street Pump Station. We are adjusting the 4th Street Pumping Station Variable Speed Pumps to achieve a more consistent flow. A new pump station is currently under construction at South 28th Street and is scheduled for completion sometime by the end of 2012; the new pump station will be equipped with variable speed pumps. We believe the ability to control influent flow into the South Plant will result in a more steady organic loading and may assist with nitrification and denitrification. Also, plant operators are working on more education in this area and working with the Pretreatment/Environmental Coordinator.

5) At this time, we feel it is best to leave BOD and TSS limits in the Metal Finishers permits.

C) REQUIRED PROGRAM MODIFICATIONS TO THE APPROVED PRETREATMENT PROGRAM

1) Calculations of Headworks Loadings reflect that the development of local limits is not necessary at this time.

Dear Mr. Suel:

The staff and administration of Van Buren Municipal Utilities has diligently searched for sources of controllable contributions of copper and zinc into the North Plant collection system as well as investigating other measures to meet the discharge limits set for this treatment facility.

We have contended that the receiving stream is in fact backwater from the Arkansas River but also understand the rigid premise used by ADEQ to set the limits.

—Please be advised that we have continued with our investigation and believe that the copper and zinc contributions are background from the domestic sewage system. We would like to determine if there is a legitimate basis for a more lenient concentration limit.

It is our understanding that the Water Effects Ration (WER) is one such potential basis for which there is precedence. We understand that there are EPA guidelines for a streamlined methodology for copper and that similar methodology may be developed or justified for zinc.

On that remise the VBMU engaged the assistance of FTN-Associates to evaluate the potential for justification of discharge limits based on the WER. To date a Biotic Ligand Model (BLM) was evaluated and the model developed gives credibility to a potential favorable WER based limit for copper that is achievable and the same may hold true for zinc.

Before undergoing the expense to determine if the WER for copper and zinc could justify revised effluent limits, we wish to know if ADEQ would consider revising the effluent limits on that basis or your reasoning if such is not considered to be a valid proposition.
