RE: Hazardous Waste Notification Requirement

Dear Radiology Associates:

The Arkansas Department of Environmental Quality (ADEQ) is requiring all wastewater utilities in the state of Arkansas, including Searcy Water & Sewer System, to notify certain sewer customers of Federal Regulations relating to hazardous wastes. At this time, the ADEQ is specifically requiring our notification of businesses who dispose of the following into the City's sewage system: hazardous waste pharmaceuticals, mercury from amalgam, and/or silver from spent film processing wastes. If your business is not involved in the disposal of any of these materials listed, you do not have to do anything and you do not have any reporting requirements at this time.

However, if you are involved in the disposal of hazardous waste pharmaceuticals, mercury from amalgam, and/or silver from spent film processing wastes into the City's sewage system; please be advised of the following regulations and requirements.

Under the specific pretreatment requirement in **40 CFR 403.12(p)(1)**, "The Industrial User [non-domestic user] shall notify the POTW [appropriate City wastewater official], the EPA Regional Waste Management Division Director, and State hazardous waste authorities in writing of any discharge into the POTW [City sewage system] of a substance, which, <u>if otherwise disposed of</u>, would be a hazardous waste under 40 CFR part 261."

Under **40 CFR 403.12(p)(4)**, "In the case of any notification made under paragraph (p) of this section, the Industrial User shall certify that it has a program in place to reduce the volume and toxicity of hazardous wastes generated to the degree that it has determined to be economically practical." You can find the full requirement with exemptions at the following website address: http://edocket.access.gpo.gov/cfr_2003/julqtr/40cfr403.12.htm.

Please be advised that if your facility does not have an amalgam separator, silver recovery unit, or system of properly disposing of hazardous waste pharmaceuticals, you may be discharging hazardous waste into the City's sewage collections system and would need to follow the above-cited Pretreatment Requirement.

Therefore, if you dispose of hazardous waste pharmaceuticals, mercury from amalgam, and/or silver from spent film processing wastes into the City's sewage system, please submit the required notifications to the following:
