GP Gurdon currently operates as essentially two separate, independent mills that share environmental permitting and management responsibilities, and was formerly overseen by a single Complex Manager. GP Gurdon believes that both the Plywood Mill Manager and the Lumber Mill Manager, together, meet the signatory requirements of 40 CFR §70.2, §122.22, and §270.11 for the entire GP Gurdon Complex.

GP Gurdon is in no way seeking to separately permit the lumber and plywood facilities, but to simply obtain the ability to certify reports and other such documents while maintaining the level of oversight and responsibility that was previously enjoyed.


