
***The site was visited on 05/13/09. The single room cabin sits on a 40 acre wooded tract of land adjacent to Beaver Lake. There is no electricity or running water to the structure. According to Ms. Tillinghast the cabin sees occasional use and all domestic waste generated during occupation is buried on the property well away from surface water. The structure is approximately 1/8 mile from the lake.***

***Waste management activities associated with the occasionally used cabin are not adversely impacting Beaver Lake. The complaint was found to be without merit.***
