WHEREAS, the Arkansas General Assembly of 1991 and 1992 promulgated the Solid Waste Management and Recycling Fund Act, Arkansas Code Annotated (A.C.A.) §8-6-601 et seq., (Act 934 of 1989, as amended by Acts 749, 751, 754 and 755 of 1991); A.C.A. §8-6-701 et seq. (Act 870 of 1989, as amended by Act 752 of 1991); Act 8 of the First Extraordinary Session of 1992; and the Landfill Post-Closure Trust Fund Act, A.C.A. §8-6-1001 et seq. (Act 747 of 1991), to develop and implement: (1) a system for the assessment and collection of fees for landfill disposal in the State of Arkansas, (2) a solid waste planning and recycling grants program, (3) an administrative grants program for Regional Solid Waste Management Districts, and (4) the administration of a landfill post-closure trust fund.

WHEREAS, under A.C.A. §8-6-601 et seq. and A.C.A. §8-6-1001 et seq., the Department of Pollution Control and Ecology was given the authority to develop rules and regulations necessary to implement the purposes and intent, as originally promulgated on January 25, 1991 and updated April 24, 1992, and to provide revisions, as presented herein, as necessitated by these amendments and additions.

THEREFORE, the Commission hereby approves the attached revised Regulation #11, Regulations for the Solid Waste Management Fees and Grants.
