WHEREAS, Act 8 of the First Extraordinary Session of 1992, codified as Arkansas Code Annotated (A.C.A.) §8-6-610, as amended, and added to Regulation #11 as Part III: Administrative Grants Program for Regional Solid Waste Management Districts in order for the Department to develop and implement regulations for an administrative grants program for Regional Solid Waste Management Districts.







WHEREAS, in order to release the funds to the districts, Regulation #11, Part III, Section 4, Requirements of Applicant. Section 4.1 states: "**Solid Waste Management Plan.** Unless otherwise excused by the Commission, the applicant must have an approved regional solid waste management plan and a waste tire management plan on file with the Department."







WHEREAS, the current fourteen districts have not complied with this requirement and, whereas, twelve of the districts have requested a waiver of this requirement and have expressed a need for release of the administrative funds to complete developing their individual plans and to proceed with the intent and purpose of Regulation #11, Part III.


THEREFORE, the Commission hereby approves to excuse the requirement, for a period of time to be determined by the Department, for the twelve regional solid waste management districts, listed below:
