On September 5, 1997, the Arkansas Department of Pollution Control and Ecology (Department) filed a petition with the Arkansas Pollution Control and Ecology Commission (Commission) to initiate rulemaking to amend Regulation No. 25. The Commission authorized initiation of rulemaking in Minute Order 97-44, dated September 19, 1997. A public hearing was held on October 27, 1997, and the public comment period extended until November 12, 1997.

In accordance with Regulation No. 8, a Statement of Basis and Purpose and a Responsive Summary to public comments was prepared by the Department and submitted to the Commission on February 13, 1998.

A review of these rule changes has been conducted by the Joint Interim Committee on Administrative Rules and Regulations and the Joint Interim Committee on Public Health and Welfare.

IT IS, THEREFORE, ORDERED:

1. That Regulation No. 25 be amended as proposed in the document dated February 27, 1998 and attached to this minute order;
2. That the Statement of Basis and Purpose and the Responsive Summary submitted by the Department be adopted by the Commission as part of the rulemaking; and
3. That the Department staff is directed to make these changes to Regulation No. 25.
