The Department of Environmental Quality (Department) has reviewed your facility's Notice of Intent (NOI) **modification**, and we have made a determination that the information certified in the NOI fulfills the required criteria for general permitting as specified in the Arkansas Plan of Implementation for Air Pollution Control (Regulation 19), the Arkansas Pollution Control Code (Regulation 18), and other applicable regulations. The tracking number for Arkansas Midstream Gas Services Corp -Sunny Hill Compressor Station located from intersection of Highway 65 and 16 W in Clinton, turn on 16W and go West 7 miles and turn South on Crowell Mt. Road and go 2 miles South and turn West (right) into GPB 1-16 and go 1.9 miles west on new road to compressor, Clinton, Van Buren Arkansas 72031, under the GOP is 1868-AGP-137. This permit and tracking number is your authority to construct, operate, and maintain the equipment and/or control apparatus as set forth in your NOI.

The permittee shall not exceed the emission limits set forth in the following table. Compliance with these limits will be demonstrated by burning natural gas.
