NOTICE OF PROPOSED AIR QUALITY REGULATION CHANGES, PROPOSED STATE IMPLEMENTION PLAN REVISION, PUBLIC HEARING, AND COMMENT PERIOD

The Arkansas Pollution Control and Ecology Commission (APC&EC) will hold a public hearing on November 2, 2018 to receive public comments on proposed changes to APC&EC Regulation No. 19, Regulations of the Arkansas Plan of Implementation for Air Pollution Control and a revision to the Arkansas state implementation plan (SIP). The Regulation No. 19 hearing will begin at 2:00 p.m. and the hearing for the SIP will immediately follow. Both hearings will be in the Commission Room at the Arkansas Department of Environmental Quality (ADEQ) headquarters building, 5301 Northshore Drive, North Little Rock, AR 72118.

The rulemaking seeks to adopt the 2015 ozone national ambient air quality standard (NAAQS) promulgated by the United States Environmental Protection Agency (EPA) on October 26, 2015 (80 FR 65292). Adoption of the 2015 ozone NAAQS by the Arkansas Pollution Control and Ecology Commission (APC&EC) is required under Ark. Code Ann. 8-4-318(b)(1) for submission by the Arkansas Department of Environmental Quality (ADEQ) of (a) state implementation plan(s) demonstrating compliance with Clean Air Act §110 requirements for the standard to the EPA. The complete filing with the Commission related to the Regulation 19 amendment can be found on the Draft Regulations page on ADEQ's website at www.adeq.state.ar.us/draft regs.aspx under APC&E Commission Docket #18-006-R.The proposed SIP revision has been included as Exhibit H in the docket for this rulemaking.

ADEQ will accept both oral and written statements at the hearings, but prefers written comments in the interest of accuracy.
