The proposed changes to Regulation No. 19 are not exempt from the requirements of Act 143 of 2007, as amended by Act 809 of 2009. Please see the attached Economic Impact Statement ("EIS") (Exhibit "E," of the Rulemaking Packet) and the attached e-mail from ADEQ staff to Ms. Pat Brown of the Arkansas Economic Development Commission ("AEDC"). On September 12, 2012, the proposed rule changes (Exhibit "A," of the Rulemaking Packet) and EIS were submitted to AEDC for review pursuant to Act 143 of 2007, as amended by Act 809 of 2009. As of September 28, 2012, more than ten (10) business days have passed, and there has been no response from AEDC regarding this proposed rulemaking.
