The Arkansas chapter of the Sierra Club has over 3,000 members. Nationally the Sierra Club represents over 2.4 million members and supporters. The motto of the club is to "Explore, Enjoy and Protect." I write to express our concern for the failure of the ADEQ to include three tributaries of the Buffalo National River on the 303(d) list of impaired waters.

The National Park Service is charged with protecting the river. Additionally the ADEQ has role as the river is an Arkansas Extraordinary Resource Water (ERW). The reach of the Park Service doesn't extend beyond the borders of the Park, but the threat to the water quality extends to the boundaries of the watershed.

The Park Service has asked for inclusion of three tributaries of the Buffalo to be included in the 303(d) list: Mill Creek, Big Creek in the upper Buffalo, and Bear Creek. It seems only reasonable, given that even thought these three streams are not themselves ERWs, they are part of the watershed of an ERW. They should therefore receive the same attention for the sake of preservation of the ERW.

Mill Creek has been a festering wound on the Buffalo for a number of years because of elevated E. coli which pollute the buffalo. Big Creek is currently stressed from the siting of a 6,500 hog factory. Real time data from a USGS gauge on Big Creek near the confluence clearly show decreased dissolved Oxygen, and elevated total Nitrogen loads which over time will degrade water quality in the nation's first National River. Bear Creek is already listed as impaired due to excessive Total Dissolved Solids (TDS), but the Park Service as asked for additional inclusion due to low DO.

The Buffalo National River is is visited by millions of tourists throughout the year, not just from Arkansas but nationally and even internationally. Over 50 million dollars of annual income is generated from this tourism. It is essential to Newton, Searcy, and surrounding counties with a rather limited income base.

It is time for Arkansans to take seriously our role as the protector of this icon of "The Natural State" and the Nation's first National River. The Arkansas Chapter of the Sierra Club, in our effort to protect the wild places within our borders, ask that you reconsider and add Mill Creek, Big Creek, and Bear Creek to the impaired streams list so they may receive specially scrutiny. We can only protect the Buffalo National River by protecting its watershed, rather than the small area with the park boundary.
