 - A. Review Reciprocity applicant, Christopher Wade Quann, last committee meeting Mr. Quann requested a Class IV and granted a Class IV license. Our Reciprocity Form only allows you to choose one license. As soon as Mr. Quann was informed that he was granted for his Municipal license he asked, what his next step was for the Industrial license. If I had been aware that he wanted his Municipal and Industrial, I would have presented both at the previous meeting. Mr. Quann has requests that we allow him to reciprocate an Advanced Industrial license even though he was previously granted his Municipal. VA does not have a separate Industrial license. Attachment with VA Requirements for a Class I -Same notes from previous meeting - The Certification of Good Standing, noted that VA stated they did not reciprocity with AR. VA explanation seemed the opposite. Called and spoke with Lisa Robinson. She stated that they do not call it Reciprocity but "Equivalency". VA will review requests and make a decision if the

operator should be granted a license. – Motion by Mr. Ward based on operators experience, Mr. Ramsfield seconded. The motion passed.

- B. Request to test for Class III for Brandon Doss. He has submitted his request via ePortal and supplied documents and transcripts to support his request. He does not hold a PE. He references Rule 3.301(D)(3) Completion of a total of three (3) years of experience in wastewater treatment or related field; provided, that at least one (1) year shall have been in wastewater treatment plant operation; When I spoke to him, he referenced Rule 3.303(A) A licensed Professional Engineer is entitled to examination for any class license through Class III. Other educational and/or work experience may qualify an operator for similar consideration by the Committee. Motion to deny by Mr. Ward, Mr. Jeff Ford seconded. The motion passed.
