Public notice is hereby given that the Arkansas Department of Environmental Quality (ADEQ) is accepting written comments from the public regarding the Notice of Violations (NOVs) listed below. Such comments must be sent to ADEQ, Legal Division, P.O. Box 8913, Little Rock, Arkansas 72219-8913, within 30 days of the date of publication of this notice. If a comment on the NOV is received by ADEQ within this time period, the person(s) submitting the comment will receive notice of any hearings held on the matter and shall have the right to petition the Commission for intervention in the matter. Any other person who reasonably considers himself or herself injured or at risk of injury in his or her person, business, or property may also petition the Commission for intervention in an adjudicatory hearing on the matter. Such petitions must be sent to the Arkansas Pollution Control & Ecology Commission Secretary, at 101 East Capitol, Suite 205, Little Rock, Arkansas 72201 and otherwise comply with all other statutory and regulatory requirements.

Public notice also is hereby given that ADEQ is accepting written comments from the public regarding the Consent Administrative Orders (CAO) listed below. Such comments must be sent to ADEQ, Legal Division, P.O. Box 8913, Little Rock, Arkansas 72219-8913, within 30 days [after publication of this Notice](#). If a comment on the CAO is received by ADEQ within this time period, the person(s) submitting the comment will receive notice of any hearings held on the matter and shall have the right to petition the Commission for a Review and Adjudicatory Hearing. Such petitions must be made within 30 days of the effective date of the CAO; sent to the Arkansas Pollution Control & Ecology Commission Secretary, at 101 East Capitol, Suite 205, Little Rock, Arkansas 72201; and otherwise comply with all other statutory and regulatory requirements.
