If a comment on any Notice of Violation is received by DEQ within this time period, the person submitting the comment will be given notice of any hearings held on the matter and shall have the right to intervene in any hearing in the matter by filing a petition for intervention with the Commission Secretary. Any such petition must be filed in accordance with applicable rules and sent to the Commission Secretary, 3800 Richards Rd., North Little Rock, AR 72117.
