

NOTICE OF TEMPORARY VARIANCE

Entergy Arkansas, Inc.  
Permit No. 0449-AOP-R11

Notice is hereby given under Ark. Code Ann. § 8-4-230(e)(1) that the Director of the Arkansas Department of Environmental Quality (ADEQ), 5301 Northshore Drive, North Little Rock, AR 72118-5317, has granted Entergy Arkansas, Inc.'s (Entergy) request for a temporary variance from its pounds per hour carbon monoxide limit set forth in Specific Condition 1 of Permit No. 0449-AOP-R11 (Permit) for a period of twelve weeks. Instead of the carbon monoxide emission limit set forth in Specific Condition 1 of the Permit, Entergy shall comply with an alternate carbon monoxide limit of 2,000 ppm on a twenty-four hour averaging basis. The temporary variance is being granted to allow Entergy to tune newly-installed pollution control equipment, low NO<sub>x</sub> burners with separated overfire air, that will ultimately result in lower emissions of nitrogen oxides. During tuning, CO emissions will vary with the goal of reducing emission to permitted levels while maintaining reductions in emissions of nitrogen oxides. This temporary variance is limited to a twelve weeks (84 days). This decision is subject to and contingent upon the right of the public to object to the Director's decision. Any member of the public may object to the Director's decision or request a public hearing within ten (10) business days of the date of this notice. Objections or requests for a public hearing will be accepted if submitted no later than 4:30 pm Central Standard Time on the last day of the comment period. Written objections or a request for a public hearing should be sent to: Arkansas Department of Environmental Quality, ATTN: Office of Air Quality, 5301 Northshore Drive, North Little Rock, AR 72118-5317.

After consideration of any timely written objections, the Director may revoke or modify the conditions of this temporary variance within thirty (30) calendar days of the date of this decision for compelling reasons or good cause shown. The Director's revocation or modification of her prior decision becomes a final decision and will be sent to the applicant and those persons who submitted timely objections. If the Director's initial decision is not revoked or modified within thirty (30) calendar days of the date of the decision, the decision is deemed final for purposes of appeal.
