

NOTICE OF PROPOSED RENEWAL PERMIT

The Arkansas Department of Environmental Quality Office of Land Resources (ADEQ) proposes to issue a Resource Conservation and Recovery Act (RCRA) Hazardous Waste Management (HWM) Renewal Permit (Permit No. 10H-RN2) to Clean Harbors El Dorado (Owner & Operator) located in El Dorado, Arkansas. ADEQ proposes to issue this proposed renewal permit under the authority of the Arkansas Hazardous Waste Management Act (Act 406 of 1979, as amended), A.C.A. §8-7-201, *et seq.* and the Resource Conservation and Recovery Act of 1976, as amended, (42 U.S.C. §6901, *et seq.*).

If approved, Permit No. 10H-RN2 will allow the continued operation of three hazardous waste commercial incinerators designed to treat hazardous and non-hazardous waste. In addition, there are numerous permitted units located on the site to store and treat waste prior to and after physical incineration. These units include tank storage units, tank treatment units, container storage units, various shredders and other mechanical processing equipment.

All persons, including the permittee, who wish to comment on the decision to issue a RCRA Renewal Permit may do so by submitting written comments, along with their name and address to ADEQ at the above street address by 4:30 p.m. on June 25, 2018. Comments submitted by mail must be postmarked by June 25, 2018, to the appropriate mailing address above. Only comments regarding the proposed RCRA Renewal Permit (Permit No. 10H-RN2) will be considered.

Persons may review the draft renewal permit and the administrative record at the ADEQ Records Management Section located at 5301 Northshore Drive, North Little Rock, Arkansas. A copy of the RCRA Application (final revision dated April 6, 2018) and proposed Renewal Permit 10H-RN2 may also be reviewed at the at the Barton Public Library, 200 E 5th St, El Dorado, Arkansas.

In addition, ADEQ will hold a public hearing at 6:00 PM on June 12, 2018. The hearing will be held in the Arkansas Oil and Gas Commission Building located at 2215 W. Hillsboro, El Dorado, Arkansas. The purpose of this public hearing is to solicit written and oral comments from the public on the proposed permit decision.

Submitting written comments to ADEQ or making oral statements on the record at the public hearing on the proposed permitting decision provides individuals with legal standing to appeal a final ADEQ permitting decision. Comments supporting or opposing the decision will provide legal standing. Only parties with legal standing may appeal a permitting decision.
