The Arkansas Department of Environmental Quality (ADEQ) proposes to issue a RCRA Class 2 Permit Modification to Clean Harbors El Dorado, LLC, located in El Dorado, Arkansas. ADEQ is issuing this proposed RCRA Permit Modification under the authority of the Arkansas Hazardous Waste Management Act (Act 406 of 1979, as amended), Arkansas Code Annotated Section 8-7-201 et seq., and the U.S. Resource Conservation and Recovery Act of 1976, as amended, (Title 42 United States Code Section 6901, et seq.).

This Permit Modification will add waste code K181 to RCRA Permit 10H-RN1. K181 is a new waste that does not require additional or different management practices from those authorized in the permit.

Individuals may review the RCRA Part B Modification Application and the administrative record in the ADEQ Records Management Section, Arkansas Department of Environmental Quality Building, 5301 Northshore Drive, North Little Rock, Arkansas, or at the Barton Library, 200 East 5th Street, El Dorado, Arkansas.

ADEQ will make a final decision on the Permit Modification request after the public comment period. ADEQ will, in response to written requests, hold a public hearing whenever the ADEQ Director determines such a hearing might clarify issues concerning the proposed Permit Modification issuance. Any request for a hearing must include the requestor's name and address and shall state the nature of the issues to be raised in a hearing. ADEQ will issue a public notice of a hearing at least thirty (30) calendar days prior to the scheduled hearing.

ADEQ maintains a list of interested individuals who are mailed copies of a Fact Sheet on or near the day of publication of a public notice relating to these proposed actions.

Any individuals, including the Applicant, who wish to comment, request a public hearing or add their names to the mailing list concerning ADEQ decisions relating to the Permit Modification, must do so by hand delivering or mailing written comments, along with their name and mailing address to: Tammie J. Submitting written comments to ADEQ or making oral statements on the record at a public hearing on the Class 2 Permit Modification decision provides individuals with legal standing to appeal a final Department decision. Comments supporting or opposing the tentative decision will provide legal standing. Only parties with legal standing may appeal the decision.
