## NOTICE OF HAZARDOUS WASTE MANAGEMENT PERMIT MODIFICATION

The Arkansas Department of Environmental Quality (ADEQ) proposes to issue a Resource Conservation and Recovery Act (RCRA) Class 2 Hazardous Waste Management (HWM) Permit Modification to Reynolds Metals Company. The facility is located Arkadelphia, Arkansas. ADEQ is issuing this proposed RCRA Permit Modification under the authority of the Arkansas Hazardous Waste Management Act (Act 406 of 1979, as amended), Arkansas Code Annotated Section 8-7-201 *et seq.*, and the U.S. Resource Conservation and Recovery Act of 1976, as amended, (Title 42 United States Code Section 6901, *et seq.*).

This RCRA Class 2 permit modification will allow all approved waste codes included in the Part A application to be stored in the Container Storage Area and Storage Containment Building. This modification also revises the sampling method from daily grab to daily representative grab. In addition, we are incorporating an agency initiated modification to RCRA Permit 30H-RN1 in Module II, Section P. 1 b & Section P. 2 to be consistent with the current financial assurance mechanism.

Individuals may review the RCRA permit and the administrative record in the ADEQ Records Management Section, Arkansas Department of Environmental Quality Building, 5301 Northshore Drive, North Little Rock, Arkansas, or at the at the Clark County Public Library, located at 609 Caddo Street, in Arkadelphia, Arkansas.

The Department will make a final decision on the permit modification request after the conclusion of the public comment period. ADEQ will, in response to written requests, hold a public hearing whenever the ADEQ Director determines such a hearing might clarify issues concerning the proposed Permit modification issuance. Any request for a hearing must include the requestor's name and address and shall state the nature of the issues to be raised in a hearing. ADEQ will issue a public notice of a hearing at least thirty (30) calendar days prior to the scheduled hearing.

Any individuals, including the Applicant, who wish to comment, request a public hearing or add their names to the mailing list concerning ADEQ decisions relating to the permit modification issuance must do so by hand delivering or mailing written comments, along with their name and mailing address to:

Submitting written comments to ADEQ or making oral statements on the record at a public hearing on the Class 2 Permit Modification decision provides individuals with legal standing to appeal a final Department decision. Comments supporting or opposing the tentative decision will provide legal standing. Only parties with legal standing may appeal the decision.
