INVESTIGATION NARRATIVE/ACTION TAKEN/FURTHER ACTION TO BE TAKEN

On Monday, June 22nd, 2015 and Tuesday, June 23rd, 2015 I received two related reports of fugitive emissions. I subsequently performed an investigation on the morning of Tuesday, June 23rd, 2015. I was accompanied on my investigation by Mr. Neil Holaway, ADEQ Inspector, Air Division.

As we approached the neighborhood, we observed no active fugitive emissions. We then performed surveillance of the facility for twenty minutes. We then made entry to the property. We subsequently met with a man who identified himself as Mr. Bryan Fox, Plant Manager, Argos Southern Star Concrete, Inc. I informed Mr. Fox of the complaint that had been made against his facility. I explained to Mr. Fox and provided a copy of the state's fugitive emissions regulations (Reg. 18.901 - Chapter 9: Control of Fugitive Emissions) to Mr. Fox. Mr. Fox stated that he had just returned from vacation, and had not been aware of any fugitive emissions from the property.

Mr. Fox, Mr. Holaway, and I then went on a tour of the facility. Although I noted no active fugitive emissions exiting the property during my time at the facility, I did note that dust was rising from several areas at the facility. These included dust from a leak at one or both of the facility's silos, dust from the end of a conveyor belt, and dust associated with equipment moving materials around. I observed the strong possibility of fugitive emissions, given the presence of just a moderate wind. There was dust piled around the facility's baghouse. Mr. Fox indicated that the baghouse had recently been cleaned out. There was one pile of wetted materials that had an actively running water sprinkler located on top of it. I gathered photographic evidence at the facility. See below attached ADEQ Official Photograph Sheets.

Mr. Fox indicated that he would take measures to better control fugitive emissions from the facility. He estimated that it would take a week or so to implement the improvements. He stated that he would contact me when the improvements had been completed.

Mr. Holaway and I then exited the facility shortly thereafter. We then performed additional surveillance of the facility. I simultaneously contacted via telephone the facility's environmental contact, Mr. Bob Bingaman, Safety/Environmental Production Manager, Argos Ready Mix, LLC. We arranged to meet with Mr. Bingaman back at the Argos facility on Amity Road. I explained to Mr. Bingaman and provided a copy of the state's fugitive emissions regulations to Mr. Bingaman. He stated that the facility's fugitive emissions could be controlled via watering. Per the Faulkner County Assessor's Office (http://www.arcountydata.com), the owner of the property at

"350 Amity Rd, Conway City, AR" was listed as "Southern Star Concrete Inc" (Parcel Number 711-07658-000C). Per the Arkansas Secretary of State website (http://www.sos.arkansas.gov), the Corporation Name was listed as "Argos Ready Mix (South Central) Corp." and Fictitious Names listed as "Southern Star Concrete".
