RE: Multiple Sanitary Sewer Overflows

Dear Mr. Mallett:

During the month of September 2008, I performed multiple SSO inspections of the city's waste water collection system in accordance with the provisions of the Federal Clean Water Act, the Arkansas Water and Air Pollution Control Act, and the regulations promulgated thereunder. This inspection revealed the following violations.

- 1. Inadequate number backup power sources for the number of pump stations maintained by the city. This resulted in an excessive number of overflows that occurred during the power outages caused by remnants of Hurricane Gustav and Ike. The pump stations that were noted as failing were: Lakeside, Fairwood, Molly Creek, Hot Spring Creek, Hot Springs 1, 2, & 3, Mazarn 1, 2, & 3, Catherine Heights, Fontana, Beverly Hills, Winkler and Carpenter Dam Pump Stations
- 2. Most of the existing backup power sources <u>failed</u> or were not adequate during the power outages. The backup power sources that were noted as failing were. Fairwood, Hot Springs 2, Hot Springs 3, Hot Springs 4, and Beverly Hills.
- 3. Excessive Inflow and Infiltration causing multiple pumps stations to overflow during these rainfall events. Gulpha Creek, Hot Springs Creek, and Hot Springs 1, all failed.
