RE: Satellite System Sanitary Sewer Overflow Investigation

Dear Mr. Keith:

On August 24, 2010, I performed an investigation concerning an overflow from a sanitary sewer manhole located south of the North Lift Station. The overflow appears to have occurred as a result of pump malfunctions at the lift station and was discovered during lift station maintenance on August 21, 2010. This investigation was conducted in accordance with the provisions of the Federal Clean Water Act, the Arkansas Water and Air Pollution Control Act, and the regulations promulgated thereunder.

At the time this investigation, it was found that the overflow cleanup had not yet been completed. Prior to my arrival at the site, the City of Centerton had used a small vactor truck to recover several thousand gallons of wastewater. I was later informed that the City of Bentonville was to assist with the remainder of the remediation. I returned to the site on August 27, 2010. Waste recovery had been completed. It did not appear that surface waters had been impacted by the overflow.

No further action is required concerning this overflow. Thank you for your attention to this matter. The Department extends its gratitude to the City of Bentonville and to the City of Centerton for their assistance with the overflow remediation.
