
Our response to the noted violation from the inspection of the Cleburne County Landfill on January 6, 2016, follows:

- (1) Regulation 607(o): Leachate leaks or evidence of leachate seepage (Specifically: Leachate leaks noted on the southwestern corner and adjacent to the haul road on the eastern slope.)

Mr. Mike Gadell, Landfill Operator, has indicated that inclement weather conditions have hampered efforts to correct the specific allegation. The arrival of snow on Thursday night, January 21, 2016, and the forecast of rain on Monday, January 25, 2016, have further complicated our efforts. Please be advised that the noted allegation will be corrected as soon as weather conditions allow.
