The Arkansas Division of Environmental Quality Office of Land Resources (DEQ) conducted a routine inspection of your facility pursuant to the Used Tire Recycling and Accountability Act (Arkansas Code Annotated § 8-9-401, *et.seq.*) of 2017, as amended, and Arkansas Pollution Control & Ecology Commission (APC&EC) Rule No. 36, and the above referenced permit. The inspection identified conditions at your facility which the DEQ alleges are violations. A copy of the inspection report is attached.


