The Division of Environmental Quality has deemed the PAER to be the product, in lb/hr, of 0.11 and the Threshold Limit Value (mg/m³), as listed by the American Conference of Governmental Industrial Hygienists (ACGIH).

Only Styrene was evaluated in this modification. All other pollutants evaluations are carried over from the previous permit.
