Layne,

On Tuesday, September 1, 2020, Georgia-Pacific Consumer Operations, LLC reported that the composite sample collected on Friday morning, August 28, 2020 (for the previous 24 hours) from Stream Monitoring Station (SMS) 002 exceeded the permitted daily TSS value of 30,000 lbs. The reported TSS value was 45,484 lbs. This upset conditions was believed to be caused by storms related to Hurricane Laura, which moved through the area on Thursday. Visual observations on the morning of 8/31/20 and 9/1/20 did not reveal any issues that would cause concern. An extra composite sample was collected on 8/31/20 (this is not at normal sampling day). TSS on this day measured 22 mg/L or 2,404 lbs/day. This is well below the permitted limit. Additionally the monthly average TSS value for August is 5,929 lbs/day, which is below the limit of 18,000 lbs/day.
