Request to remove Dieldrin monitoring requirements

Dear Mr. Uyeda:

Georgia Pacific Crossett Paper Operations' was issued NPDES Permit # **AR0001210** with an effective date of November 1, 2010. This renewed permit required monitoring of Dieldrin at SMS 002 except during flood conditions when monitoring is conducted at Outfall 001. Georgia Pacific is required to achieve final permit limits within three years of the effective date. There have been no detections of Dieldrin in any of the monthly samples collected during this interim period. Please see attachment for a summary of monitoring results.

Georgia Pacific LLC would like to formally request that Dieldrin monitoring requirements be removed from the permit as allowed by Part I, Section B, Condition 3 of the NPDES permit.

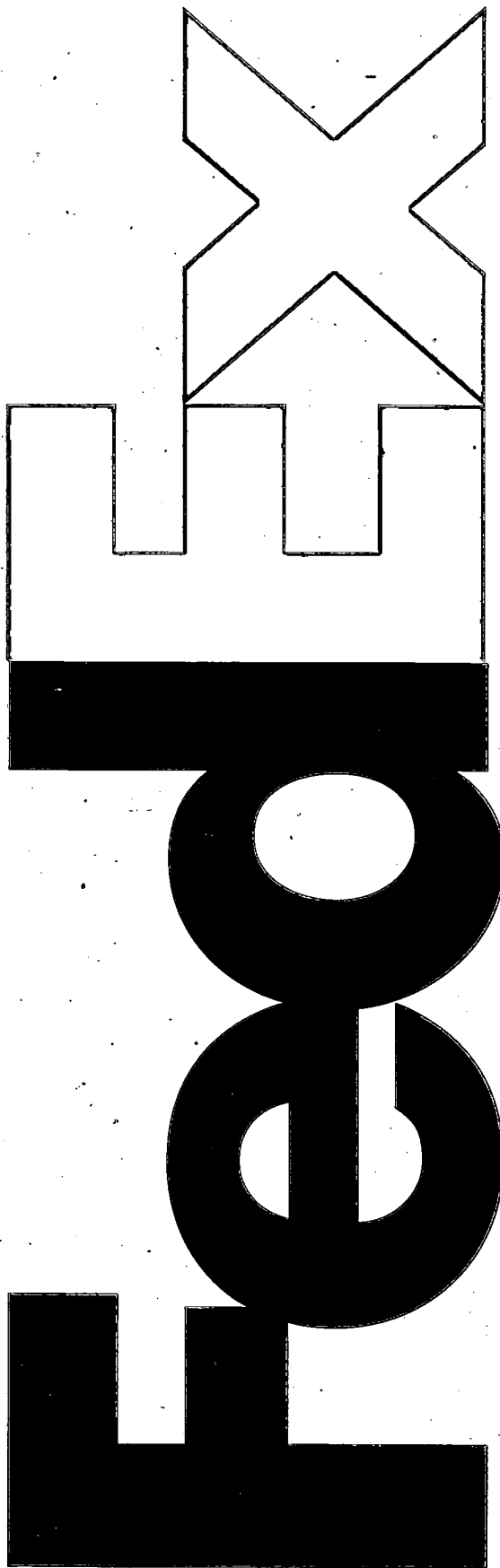

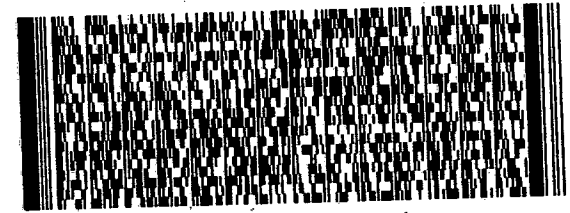

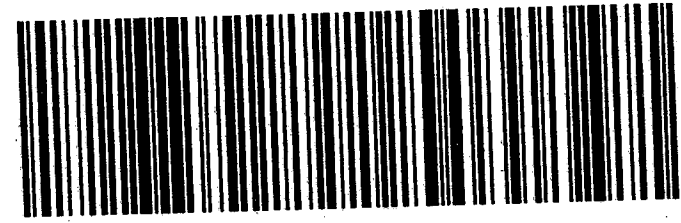
