Attached are the Discharge Monitoring Reports (DMRs) for the Georgia-Pacific Crossett Paper Operations' - NPDES Permit # **AR0001210** - for March 2016. As previously reported to ADEQ via email dated March 10, 2016, effluent flow from Outfall 001 could not be measured on March 9 and 10, 2016, due to the extremely heavy rainfall that occurred during that time. The large amount of storm water caused the water level to flood over the flow measuring device and outside the flume structure. Samples were collected for Biochemical Oxigen Demand (BOD<sub>5</sub>), Total Suspended Solids (TSS) and Adsorbable Organic Halogens (AOX); however, accurate mass loading calculations cannot be made since the flow could not be measured. Two additional samples were collected the following week above the required three per week.
