Attached are the Discharge Monitoring Reports (DMRs) for the Georgia-Pacific Crossett Paper Operations' - NPDES Permit # **AR0001210** - for January 2015. Please note that Mossy Lake became flooded on January 4<sup>th</sup>, when the Ouachita River rose above 62 feet. Therefore only one sample was collected for BOD, TSS and pH analysis at SMS 002 during this monitoring period. Monthly samples for Metals, Nutrients and Dieldrin are normally collected on the first Tuesday of the month; however due to the sudden flooding of Mossy Lake these were not collected during this monitoring period. These parameters were monitored at Outfall 001 as required by the NPDES permit.
