## Good morning Ms Graham,

I wanted to send notification that an unpermitted release of W3-effluent was discovered and resolved at the Paul R Noland WWTF (AFIN 72-00781, AR0020010) yesterday (Thursday, May 18) morning.

The discharge of fully treated W3-effluent occurred from a buried line break next to the facility's remnant W3-water meter located just northwest of the Administration Building.

- Use of W3-effluent for landscape maintenance was formerly allowed under permit No. 4748-WR-4 (Part 2, SPL. COND. 17); this allowance was not carried over into permit renewal No. 4748-WR-5 (eff. Jan 01, 2021) as it had been many years since the practice of facility-landscape W3 irrigation had been employed.

Initially the discharge was stopped by shutting off the facility's W3 pumps around noon.

Excavation of the area confirmed a break in the 2" W-3 line (near the W3-water meter) which was most likely caused by abrasion against a buried rock in the adjacent backfill.

Staff have removed the section of broken pipe and the former W3-water meter since W-3 landscape irrigation is no longer practiced, or permitted, at the Noland facility.

The 2" W3 line has been terminally capped off and will remain unavailable for use.

An estimated 500,000 gallons of fully treated W3-effluent is estimated as released onto facility grounds and into a nearby intermittent (unnamed) tributary to nearby White River.

No adverse environmental impacts have been observed and none are expected.
