Good afternoon Ms Graham,

I wanted to send notification that early this morning (Thursday, July 20th) Maintenance staff received a call-in notification that SSO evidence was found at a manhole located near the Mally Wagnon Lift-station (No.19) connected to the Paul R Noland WWTF (AFIN 72-00781, AR0020010)

After verifying a dislodged manhole cover (at SSM-11336), and the presence of nearby debris, we believe a SSO did occur from this location starting late Friday night (July 14th) and ending early Saturday morning (July 15th).

We were aware that area storms and lighting (Friday night, July 14th) caused a brief loss of COMM-controls which left lift-station pumps offline for a brief interval. The On-call technician had liftt-station controls back online by 12:45 AM Saturday morning, with all station pumps fully operational.

The following morning, after the storm and during daylight hours, Maintenance staff inspected the area for signs of SSOs without finding evidence that any overflows occurred, although the SSM-11336 location was not noticed.

Again, based on this morning's observations we believe a SSO occurred sometime between 11:00 PM (7/14) and 12:45 AM (7/15) with an estimated 100,000 gallons overflowing into an unnamed tributary to the West Fork White River.

Lift-station No.19 continues to be fully operational, manhole SSM-11336 has been re-secured, debris removed, and lime applied to SSO impacted areas.

No adverse environmental impacts have been observed, and none are expected.
