The above referenced CAO has a final compliance deadline of December 31, 2023. Due to extended lead times for the new clarifier equipment, the existing clarifier rehabilitation has been delayed from the previously anticipated schedule outlined in the Corrective Action Plan (CAP). SALT Engineers, on behalf of the City of Mountain View, is formally requesting a 6-month extension of the final compliance deadline. This would revise the final compliance deadline to June 30, 2024. The City has been making steady progress on the WWTP Improvements and would appreciate the Department's consideration of this requested extension.

Please accept this email as the quarterly progress report for CAO LIS No. 18-091 - City of Mountain View (AR0020117). The project is currently in construction and the new clarifier is almost complete. We expect to be able to switch flow to

the new clarifier sometime later in July or early August and then begin work on the rehabilitation of the existing clarifier. An extension request for the final compliance deadline will be submitted to request an extension to June 30, 2024. The extension is needed due to the long lead times that were required to receive the new clarifier equipment which has pushed the existing clarifier rehab work to late summer and fall of 2023. This will not leave adequate time for rehab and start-up by end of year 2023.
