- DMR End Date 09/30/09, Discharge 001A- DMR did not include a sample measurement for Nitrogen, nitrate total (as NO<sub>3</sub>)(Monthly Average, lb/d)
- DMR End Date 11/30/09, Discharge 001A- DMR not received at the Department.
- DMR End Date 02/28/10, Discharge 001A- DMR did not include a sample measurement for Nitrogen, nitrate total (as NO<sub>3</sub>)(Monthly Average, lb/d)

Please submit the delinquent/deficient DMR's and any applicable non-compliance reports to the Department by January 10, 2011. Each DMR must include an original signature and date by the Principal Executive Officer or Authorized Agent.
