Effluent Violations and CAP Updates Request

Dear Ms. Taylor:

This is in reference to your letter dated June 16, 2017. On the effluent violations some of the issues are due to the construction phase we were doing on our digester, also the excessive rainfall we have had during this time period, and are still having occasional down pours to date. In August of 2016 we received 12.4 inches of rain. Lift Station #1 had an issue due to construction. A few times the aeration was out of adjustment, which was corrected. The aerobic digester was completed and released on January 5, 2017 with a warranty period up to January 2018. In October 2016 we started rehabilitation project CTA NO. 16705400 to replace old Line #1 from manhole 81 to manhole 91, approximately 3500 feet of old 6 inch clay line that lays on the south side of Highway 66 west with a 8 inch PE SDR17 pipe using the pipe bursting method. We also did a road bore across Highway 66 West at about old manhole 85 and upgraded this from a 6 inch to an 8 inch line with one new manhole on the North side of road. We are trying to address any problem areas we find as long as funds and manpower are available. We repaired a manhole near the property of 205 Meadow View, which flows to the lift station on Riggsville Drive. We capped off the lines at the old fire station east of town that was destroyed by the tornado. We are working on adding a new lift station in the area of Maple Drive and Downey Drive this year. In the March 2016 letter we stated that we still have about 85 manholes that needs to be rehabbed, and we are still trying to work these into our schedule. We will continue to address customer's service lines as they do have an impact on the SSO along with the heavy rains we have received.

We found a couple of manholes in the school area that were in a low area and those were raised and repaired. We hope that what we have done so far and will continue to do will bring everything back into compliance.

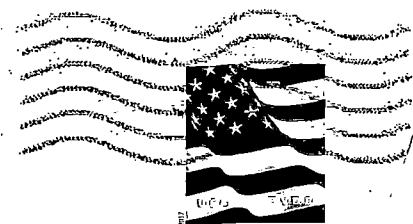
