The City of Batesville offers the following report of Sewer System Rehabilitation in accordance with the above-captioned Consent Administrative Order.

Sewer System Rehabilitation

The City of Batesville completed a Sewer System Evaluation Survey (SSES) in August 2011 which identified parts of the sewer system that required, or may require, sewer line repair or replacement. The attached table titled "Batesville Water Utility Sewer System Rehabilitation Summary" sets out the various tasks that the city has chosen to perform with city forces or sewer service customers.

Based on funds, the City will be prioritizing the remaining rehabilitation work based on Pipeline Analysis' recommendations for Priority 1 and Priority 2 work. The City and Olsson continue to work on construction documents for the Priority 1 sewer system rehabilitation to be performed by contract. The attached table shows the remaining Priority 1 work to be completed per the upcoming construction documents. Plans and specifications for this work are estimated to be finalized in March 2023, with construction starting soon after.

Pipeline Analysis defined the Priority 1 and Priority 2 work in their executive summary as follows: "Priority 1 defects are severe and are recommended for immediate attention, while Priority 2 defects are recommended for repair as funding allows." Based on these recommendations, Priority 2 rehabilitation work as well as problems that have emerged in the

years since the 2011 SSES was performed shall be completed by the City maintenance staff annually as budget allows.

Rehabilitation of Private Service Lines

The bottom section of the table sets out the sewer service line rehabilitation identified in the SSES. There are 288 items of work that were identified in the SSES. Per the previous progress report, city staff had completed 96% of the items set out in the SSES for repair. Since the previous report was submitted, the City has worked with property owners to address the remaining items on the private service lines.

Mainline Construction

The City of Batesville continues to place a high priority on the remediation of sewer system defects and the goal of mitigating sewer system overflows. As indicated in our June 2021 report to ADEQ, the city received bids on February 9, 2021, for the Contract Section 3 – Primary Interceptor Sewer Improvements project and the contractor was issued the Notice to Proceed on March 9, 2021, with a substantial completion date of February 7, 2023, and final completion date of March 9, 2023. At the time of our November 2022 partial pay estimate/NRD disbursement request, the percent of the Contract Section 3 construction contract completed was 78.19 percent with 89.43 percent of contract time used based on the substantial completion date above.

Currently, issues with railroad permitting and subsurface soil conditions have caused delays with the trenchless construction. Due to these issues, the general contractor has indicated that the mainline construction will not be complete in March 2023 as originally intended and anticipates final completion in June 2023.
