

The Corrective Action Plan for the City of De Queen wastewater plant past ammonia nitrogen violations are as follows.

8/2011- 2 of the 4 blowers were out of service at the same time, the dissolved oxygen could not keep up with demand as sometimes 3 blowers are need for treatment.

CAP – A new blower was purchased and another repaired in August 2011, all 4 are online, it was discovered that when running at 100% this would overdrive the units causing premature failure, all blower drives are set to max at 70%.

5/2012 – Spring rains had increased the level on pond, the gate was opened to run this excess water back through plant for treatment, the amount was too much for system to handle.

CAP – The pond water is now tested before running back through plant and adjusted as per treatment.

1/2014 - Cold temperatures in system caused a slowdown in treatment of ammonia nitrogen.

CAP- The solids retention time was too short for treatment (16 days) this was increased to (+ 20 days) in January. The SRT is adjusted seasonally as needed now.

3/2014 – Nitrifiers were lost in MLSS, reason is not known.

CAP – 200lbs of nitrifiers were purchased and dosed in plant at a cost of \$8,000.00 in March, this source for nitrifiers has next day if needed in future.

The City of De Queen wastewater plant is in compliance with ammonia nitrogen at this time, every effort is being made to stay in compliance now and in the future.
