Alan,

We wish to inform you of a partially treated effluent discharge at the Berryville WWTP. At approximately 2:00 a.m. on 21 July, 2015, a mechanical failure in the UV disinfection system allowed an estimated 517,000 gallons of partially treated effluent to discharge from the treatment facility. Necessary repairs were completed and the UV system was placed back into operation at approximately 9:00 a.m. Besides UV disinfection, the discharge received treatment from all treatment processes at the facility.

No environmental impact has been observed and none is expected.
