The amended Consent Administrative order, CAO LIS 18-066-001 requires a registered professional engineer in the state of Arkansas to provide a Certification of Compliance for the city of Monticello (City) on or before September 30, 2021. The City cannot satisfy all the terms and conditions in the said Order at the stipulated period.

On behalf of the city of Monticello, McClelland Consulting Engineers, Inc. (MCE) respectfully requests for an additional time to satisfy the said Order. This unanticipated request is due to the following:

1. The ongoing Pandemic has disrupted almost all business activities state wide; consequently, businesses and cities are trying to clear backlog of construction activities and other events.
2. To date, the Arkansas Division of Environmental Quality (DEQ) has not issued the land application permit to the company that will remove the sludge from the lagoon. The sludge removing company applied for the land application permit since November 2020, and there are no insights when DEQ would issue the required permit.

Based on the above premises, the City would appreciate it if DEQ would extend the final compliance date.
