Please submit the deficient/delinquent Discharge Monitoring Reports and any applicable Non-Compliance Reports to the Department by December 3, 2010. Each DMR should include an original signature and date by the Principal Executive Officer or Authorized Agent.

Any violation of your NPDES Permit is subject to enforcement action by this Department, pursuant to the Arkansas Water and Air Pollution Control Act. The regulations and your NPDES Permit require that you take all reasonable measures necessary to eliminate or prevent the occurrence of violations. <u>The NPDES file for the City of Monticello-East Plant will be reviewed again in January 2011 in order to determine if formal enforcement action is necessary.</u>
