Good morning,

The letters I previously sent were a warning for past violations. The violation for March 2023, as cited in the East Plant's letter, already has a NCR submitted, so that one was for notification purposes only and no further action is required for it. The two NCRs I'm needing – one for the East Plant, one for the West – are for <u>December 2022</u> violations reported on the <u>001-Y</u> DMRs, as each are reported as NODI Code E (no analysis conducted). For this period, East violated Total Recoverable Mercury; West violated Phosphorus, Total Recoverable Mercury, and Nitrite + Nitrate. NODI E is a violation and requires an NCR detailing why analysis was not conducted and how that will be avoided in the future. I do not have record of NCRs for these two DMRs being submitted. These are the NCRs I am requesting

As for April and May 2023, as mentioned in your previous email, no NCRs are necessary. Reporting NODI Code C (no discharge) is not a violation.
