The City of Eureka Springs NPDES Permit AR0021865, Part II, Condition 6, states any SSO (or any amount) if it discharges to waters of the state must be reported to DEQ with 24 hrs and therefore the conditions in the DEQ's letter date October 11, 2023, must be undertaken for any SSO (Bypass, Upset Condition or Unpermitted discharge) at the WWTP which discharges to Leatherwood Creek. The 15,000 gallon amount is not appropriate.

Sanitary Sewer Overflow (SSO) Reporting Requirements:

A. A sanitary sewer overflow is any spill, release or diversion of wastewater from a sanitary

sewer collection system including:

1. Any overflow, whether it discharges to the waters of the state or not.

2. An overflow of wastewater, including a wastewater backup into a building (other than

a backup caused solely by a blockage or other malfunction in a privately owned sewer

or building lateral), even if that overflow does not reach waters of the state

ACTION #2

We believe that the unpermitted discharges have been eliminated at this time. The last time we had an unpermitted discharge was September 20, 2023, so It has been three weeks since our last unpermitted discharge. We believe the unpermitted discharges have been eliminated for a couple of reasons: 1 – The MLSS numbers have been reduced as a result of increased sludge wasting; and 2 – The issue with erroneous water level readings in our SBR basins has been resolved with the location of a faulty connection between the pressure transducer and the wiring connecting to the PLC which controls the operation of influent and effluent valves, the blowers and motive pumps. I have not taken pictures of our post aeration basin prior to disinfection and discharge, or of the discharge during a decant event from the creek level, but plan to take those pictures first of next week and forward them to you.

ACTION #3

The bacteria sampling requested in action #3 was initiated today. We were unable to begin on Thursday because we had to acquire additional sterile sample bottles from our contract laboratory before we could begin the sampling process. This delay also allowed them a chance to make changes to the work schedule of employees to accommodate receiving samples and performing test analyses on the weekend. We have made plans with our employees to continue the sampling process until we have test results for two consecutive tests that meet the sample result criteria of less than 126 colonies per 100-ml.

ACTION #4

The monitoring and sampling as requested in action #4 will be continued until the results from the sampling on two consecutive testing dates meet the water criteria requirements of less than 126 E. coli bacteria per 100-ml of sample. We will pull samples at least every three (3) calendar days with the lab results and chain of custody emailed to the Arkansas DEQ Office of Water Quality Enforcement Branch upon receipt of lab results. The GPS coordinates for each sample have been added to the chain of custody as part of the sample identification.
