

RE: UPDATE ON ACTIVITIES FOR CORRECTIVE ACTION PLAN WEST MEMPHIS UTILITIES
NPDES PERMIT NUMBER AR0022039, AFIN 18-00879

Dear Mr. Hickey:

On behalf of West Memphis Utilities (WMU), please accept the following as an update of activities undertaken since our last update in June 2022. As outlined in WMU's Amended CAP, WMU outlined a plan of action through December 2023. Listed below is a capsule summary of those activities either completed or underway since the CAP was implemented.

- 1. WMU continues to meet monthly with their CAP Working Group. Members of this group include Todd Pedersen, General Manager WMU; Ward Wimbish, Asst. General Manager, WMU; all engineers with WMU; Denise Bosnick, Director of Environmental Quality, WMU; and Paul Holloway, WWTP Manager, WMU. Also included in these monthly meetings as necessary are Tim Verner, P.E., and Chase Carpenter, Fisher & Arnold, and Mac Compton, P.E., RJN Group. This group directs and tracks on-going efforts by WMU staff and all outside consultants and contractors relative to efforts towards the elimination of systemwide SSOs.
- 2. Argo Construction continues with the installation of a new common force main to convey sewage from Pump Stations 3 and 4. They are approximately 40% complete with this work and will soon begin the reconstruction/replacement of each of these pumping stations. This project has a Substantial Completion date of July 1, 2023.





- 3. Since our last semiannual report in June 2022, WWTF staff has not had any reported plant bypasses. Additionally, since June 2022, there has been one reported sanitary sewer overflow in October.
- 4. Approval of the modifications to the WWTF expansion have been obtained by ADH and ADEQ with final Permit modifications currently in the Public Review period. It is anticipated that WMU will move forward with the advertisement for bids on this work in early 2023.
- 5. Between the period of June 25, 2022, and November 30, 2022, WMU has invested an additional \$1,531,419.73 in the planning, engineering, replacement, and/or repair of their sewer collection and treatment systems. Of this total, \$1,460,527.72 has been for actual rehabilitation, replacement, or upgrades of existing infrastructure. The remainder has been for advance planning studies and/or design of sewer infrastructure repairs, rehabilitation, or replacement.
- 6. WMU's contractor has completed twenty-three of the forty-four-point repairs to existing sewer mains and laterals with an expected completion date of late February 2023. The completion of these repairs will then allow WMU to move forward with the commencement of CIPP of existing gravity sewer mains identified in previous SSES Reports prepared by RJN. This CIPP work is planned to commence first quarter 2023.
- 7. WMU is planning to commence 60 to 75 days of post-rehabilitation flow monitoring after the completion of the work to Pump Stations 3 and 4, and the scheduled CIPP work referenced above.

Hopefully, this summary of activities is useful to you and your staff and demonstrates the commitment of WMU to eliminate SSOs in their collection system and WWTP bypasses. If you require any additional information, please do not hesitate to contact me at this office.

#### D. 2022 FLOW MONITORING

 Compton suggested that the flow monitoring study needs to be done altogether because of flow from pump stations 3 and 4 and the new force main that will Be complete in the spring. Suggested to do it during the spring season.

#### E. 2022 SEWER MAIN REHAB.

- Elhaj stated that the notice to proceed has been issued to Water & Wastewater Services on June 7, 2022.
- Elhaj stated the 2022 sanitary sewer point repairs will be complete in early December. The point repair includes 42 locations and two laterals.
- Elhaj stated that WMU has identified sewer mains that need to be cured in place pipe. The next step will be putting bid package together.

### A. Review Meeting Minutes:

### **B.** Common Force Main Extension and Pump Stations:

Only item from Tim Verner was the application for payment made from Argo for their work through the end of last month (September). Tim asks if the directional bore had been done, the 900 feet that goes from Rich to the east side of the fire station on West Barton and it has been done. They also request 550 feet open cut force main. Todd asks if the jack tap had been made and Tim said it was made last month (September). This was Argo first application for payment.
