The purpose of this correspondence is to provide a quarterly project update for the South Lift Station Forced Main Upgrade Project.

- The project design has been revised to coordinate conflicts discovered comparing to construction drawings as well as actual construction of Arkansas State Highway 12 utility relocations. Final drawings and specifications have been submitted to the Arkansas Department of Health, Army Corps of Engineers, and the Arkansas Highway and Transportation Department for review and approval.
- Easements associated with Arkansas State Highway 12 utility relocations have been obtained to include the proposed 16-inch force main. The City has 14 easements remaining to acquire. Easement documents are final and property owners have been initially contacted or will be contacted no later than April 4, 2014. Easement acquisition is anticipated to be complete by the end of April 2014. Once all easements have been acquired, bid documents will be prepared. Advertisement for bids is expected to occur during the month of May with bid opening in June 2014.
